Dear Residents of the Village of Walton Hills:

As we prepare for the New Year and close out 2012, I am proud to say that we have exceeded our expectations regarding the operation of our Village. We began with a budgeted deficit in January 2012 of approximately \$750,000. We asked Council in June for an additional \$200,000 to cover the cost of various road projects and our police dispatching for Oakwood, which increased our deficit to \$950,000. However, our revenues far exceeded our expectations and we made several cuts to our budget. I am excited to say that we should end 2012 with an approximate deficit of \$300,000, pending our Egbert Road reimbursements, which is a \$650,000 savings from our initial projection!

I am very thankful to live and work in our Village which is blessed to have so many more *givers* than *takers* living here. We must recognize the *givers* and applaud and appreciate them for what they do to try to make life better for all the people that they come in contact with on a daily basis. If we recognize the *givers*, then with sadness we also have to recognize that we have some *takers* in our Village as well, as do other communities. A *taker* is someone who never offers help or solutions to problems unless it benefits them or their cause. A *taker* is someone that is always complaining but never rolls up their sleeves or gets involved to find a common ground. Let us all try our best to tolerate and work with the *takers*. Let's never forget that our nation **was not built on takers**. It was built by men and women that were *givers* that gave the greatest gift of all – sacrifice, which is best represented by our military on a daily basis. That is why we still live in the greatest nation in the world - and our Village is proud of the great *givers* that live and work in our community.

As we face 2013, let's face it with optimism and know that we are going to continue to thrive and be successful. This can only be accomplished with *givers* and positive people. So I want to wish everyone a very happy and blessed New Year and I want everyone to be positive in their outlook for the New Year!

Walton Hills Community Block Watch

Crime prevention as each citizen's duty is not a new idea. In the early days of law enforcement, well over a thousand years ago, the peace keeping system encouraged the concept of mutual responsibility. Each individual was responsible not only for his actions, but for those of his neighbors. A citizen observing a crime had the duty to rouse his neighbors and pursue the criminal. Peace was kept for the most part not by officials, but by the whole community.

By applying here as a block watch member, you are helping the Village of Walton Hills' Police Department to protect you and help keep your community safe. Neighbors working together in cooperation with law enforcement can make one of the best crime fighting teams around. Block watches are crime prevention programs that enlist the active participation of citizens in cooperation with law enforcement to reduce crime in neighborhoods. It is a free program and involves getting acquainted with your neighbors, looking out for one another, and learning more about crime prevention.

WHY A BLOCK WATCH? The block watch program opens the lines of communication between neighbors, from citizens to the Police Department, and from the Police Department to the citizens. Good communication includes tips, tools and information, as well as crime reporting. It enables the neighborhood to be the eyes and ears of the Police Department, plan coordinated action and have resources on which to draw from in times of trouble. Focusing on direct communication between police officers and citizens gives officers a sense of support from the community, and gives the citizen the sense that officers are not just faceless uniforms but human beings who care about the communities in which they work. Good communication increases understanding from both perspectives.

SECURITY: The block watch program provides security information. This information can be used to increase your security at home, whether you live alone or with other family members. Enhancing the security of your environment reduces the chance of a burglar gaining entry to your home, and may minimize property loss in the event of an entry.

EDUCATION AND INFORMATION: The block watch program provides a monthly newsletter with crime prevention information and statistics. This assists residents in accessing Police Department and Village services and gives you current information such as tools and risks, which can assist citizens in planning, preparation and crime prevention.

STRENGTH IN NUMBERS: There is a political and practical strength in speaking in loud, unified voices, whether to the Police Department, the Village, or legislators, or in speaking to the neighborhood and the community. Additionally, working as a group makes citizens stronger against crime and fear, and reduces the burden that any one citizen must carry for the group.

Dear State Representative Anielski:

Enclosed herein please find a copy of the Resolution opposing HB 601 passed by the Council of the Village of Walton Hills. HB 601 eradicates Home Rule and this Village pledges to oppose and/or challenge the State's right to dictate Municipal or Village tax rates, tax collection, audit opportunity or any other Home Rule authority afforded our Village.

It is our ardent hope that you will not support HB 601 with your vote.

Further, we would like you and your fellow legislators to concentrate your efforts on attracting business and industry to locate in Ohio, specifically to help Walton Hills Village fill the void that will be left when Ford Motor Co. shuts down the Walton Hills Stamp- ing Plant.

In addition, the Ohio Legislature has failed to fulfill the Ohio Supreme Court's mandate in the DeRolf litigation to find a constitu- tional method to fund public education in Ohio. This mandate should be immediately addressed and we ask that you personally present this issue to the Ohio House of Representatives and/or offer your proposal for satisfying the Ohio Supreme Court's mandate for the Legislature's consideration.

Simply put, Walton Hills Village would like to see a redirection of the Ohio Legislators' efforts away from the eradication of Home Rule, and more to promoting the State of Ohio and providing incentives to businesses relocating or locating in our State. Please by all means attend our council meetings and start communicating with our Village about the direction of our State Legislature. We ask you to please represent our Village in finding a solution to the funding of our school system.

We look forward to reading your proposal to the Ohio Supreme Court regarding the constitutionality of the method being used to fund the public education system in Ohio and we look forward to your active involvement in our community's needs.

1/2% Income Tax Increase on May Ballot

On November 6, the Walton Hills' voters opposed Issue 99 which would have increased the Village's income tax rate from 2.0% to 2.5%. The vote was not close as 778 (54.33%) opposed the increase and 654 (45.67%) voted for the increase. The Administration and Council have concluded that the income tax increase was not communicated well to all the voters, therefore the issue will be placed one more time on the May 2013 ballot.

Here are the major points on why the Village is once again proposing the increase:

- ⇒ The Village's fund balance (retained earnings) has decreased from \$10,479,005 at the end of 2005 to \$4,404,658 at the end of 2011;
- ⇒ The two largest sources of revenues, income tax and interest earnings, were averaging approximately \$4.8 million annually for the three years 2005 through 2007. The annual average amount since then is approximately \$3.5 million;
- ⇒ The State of Ohio is eliminating the estate (inheritance) tax beginning in 2013. The Village received over \$200,000 in estate tax in 2012;
- ⇒ The State of Ohio has significantly decreased its distributions to counties and municipalities. The Village received approximately \$78,000 annually from 2004 through 2011. The estimate thus far for 2013 is \$21,000; and
- ⇒ The Ford Motor Company, which has provided our Village with over \$25 million in payroll taxes from 1990 to 2011, will most likely close its operations here in less than three years.

To put the Ford impact on our community in perspective, a Walton Hills residential property owner pays the Village less than \$20 annually on a home value of \$200,000. With approximately 1,000 homes, the Village receives \$20,000 in property taxes annually from its residents. Ford submitted more than \$700,000 to the Village in payroll taxes for 2011. It would take 35 years of the current property tax rate for the residents to match what Ford remitted to the Village in just one year. This does not even compare to what Ford remitted to the Village in prior years as listed below:

- ⇒ 1994 tax rate 1.00% **\$1,389,135**
- ⇒ 2004 tax rate 2.00% **\$1,621,891**

The impact of Ford may have been taken for granted over the years as it allowed the Village to assess one of the lowest municipal property tax rates in the State. It also allowed the Village to pay for residents' sanitary sewer bills through 2010.

Surrounding communities are taking an even bigger hit as to the elimination of the estate tax and reductions in State distributions. Next year, the cities of Maple Heights and Bedford will be receiving \$893,612 and \$337,090 less in State distributions via Cuyahoga County when compared to the same distributions in 2005.

The Village has taken steps to reduce its expenditures by doing more with less. Full-time employment has been reduced from a high of 35 in 2008 to the current level of 24. The Village has consolidated responsibilities amongst the existing full-time employees and are utilizing more part-time employees.

A tax increase from 2.0% to 2.5% proposes to generate the most funds with the least amount of impact to its residents and businesses. Income taxes collected should increase approximately \$875,000 of which approximately two-thirds will be paid by non-residents working in Walton Hills.

SPOTLIGHT ON THE DINER ON NORTHFIELD ROAD

One of the many threads in the fabric of our Village

The Diner on Northfield Road has a simple philosophy: “100% guest satisfaction 100% of the time.” In addition, everything they serve is 100% homemade – nothing they prepare has ever been frozen. Sounds like the perfect recipe for a successful restaurant! Owner Jim Musarra is very proud of his diner located at 7188 Northfield Road in Walton Hills, at the corner of Krick Road and Northfield Road. He opened the restaurant on August 15th of this year.

Jim did not start out in the restaurant business. He was a National Sales Manager for Wilkinson Sword razor blades and was transferred to Atlanta, Georgia. He received a large bonus check and decided to go into business for himself. He opened two restaurants in Atlanta in 1984, which he ran for about ten years. He then came back home and became the Director of Operations for the Brown Derby Roadhouse, a position he held for approximately 14 years. He next became the General Manager of the Freeway Lanes bowling alley and then decided it was time to open his own business again and The Diner on Northfield Road was born! It is a family establishment - Jim’s son, Christian Michael, works at the restaurant as an “all utility employee” and his wife Linda helps out.

The Diner on Northfield Road has an extensive menu for breakfast and lunch. The cuisine would be classified as American with traditional breakfast favorites and daily breakfast specials being offered. Breakfast is served all day. The lunch menu includes soup and chili, salads, burgers, sandwiches (chicken, club, BLT, grilled cheese, fish, gyro, ribeye steak), hot dogs, and wraps. In addition, Chef Greg Baily from New Orleans prepares daily Cajun specials such as chicken and sausage gumbo or jambalaya. Besides the one Cajun special, there are also two or three daily lunch specials. They also offer a homemade veggie burger and a vegetable wrap, which will delight vegetarians! A kids menu is available for both breakfast and dinner.

The Diner on Northfield Road is open Monday through Friday from 6 a.m. to 4 p.m. and on Saturday from 7 a.m. to 2 p.m. They are closed on Sunday. They offer take-out and they will deliver. They welcome private parties any day of the week after 4:00 p.m. with no additional charge for the use of the restaurant. They can tailor any party to your budget.

Jim had a busy November and December. His Thanksgiving promotion was very successful – a whole turkey and four side dishes were cooked for patrons to pick up for their family celebrations. They also had a Christmas promotion where a complete ham or turkey dinner was prepared for take-out and a New Year’s promotion which offered a complete pork loin, ham or turkey dinner for take-out. Keep all of this in mind for your next Christmas and/or New Year’s celebration! There will also be an Easter promotion which is still in the planning stages.

EDUCATION ALTERNATIVES

St. Benedict School



Bus transportation is provided to St. Benedict School for the children of Walton Hills

The mission of St. Benedict Catholic School, located at 13633 Rockside Road in Garfield Heights, is to provide an excellent Catholic education rooted in the Gospel message of peace, acceptance, understanding and service to others for all children in our community. Their vision is to strive to expand the mission of the Catholic parishes of our community and to serve the needs of an evolving society by instilling a spirit of Catholicity and providing an innovative, superior academic program that meets the needs of all children in a financially fit school that is affordable and accessible to all families who desire it.

St. Benedict was formed for the 2012-2013 school year when the parish schools of St. Monica and St. Marin of Tours were combined. This did not happen because of low enrollment or financial problems for either parish. Both parishes were proactive in forming the new school, which provides one strong Catholic school for the neighborhood. Students from all faiths are welcome, but all must participate in Catholic religion classes and attend mass once a week. Kindergarten through eighth grade is taught at St. Benedict. Their students come from Bedford, Garfield Heights, Independence, Maple Heights, Sagamore Hills, Lyndhurst, Broadview Heights, Cleveland Heights and Walton Hills. Nine students from Walton Hills attend St. Benedict.

St. Benedict is committed to academic excellence by providing a wide range of educational services to meet the needs of a student body that is diverse in its abilities. Core academic subjects are taught at the school. Computer education is integrated into the curriculum of kindergarten through eighth grade to provide students with all necessary technical skills. All students, starting in kindergarten, are required to study the Spanish language. They offer an accelerated reading program in kindergarten or as early as a student learns to read. St. Benedict has a fully equipped science lab and art and music rooms. They also have an enrichment program and have a fulltime intervention specialist on staff. They have small class sizes, averaging 23 students.

St. Benedict School offers various additional opportunities for students to supplement their educational experience. They offer a cooking club, a computer club, an art club, a poetry club, an astronomy club, a choir club, and a Junior Holy Name Society Club. They also offer an Academic Challenge, a drama ministry, a band program and a CYO Athletics program.

According to Principal Lisa Oriti, St. Benedict is awesome – the positive energy at the school is overwhelming, and everyone is excited about the changes and the academic programs offered.
